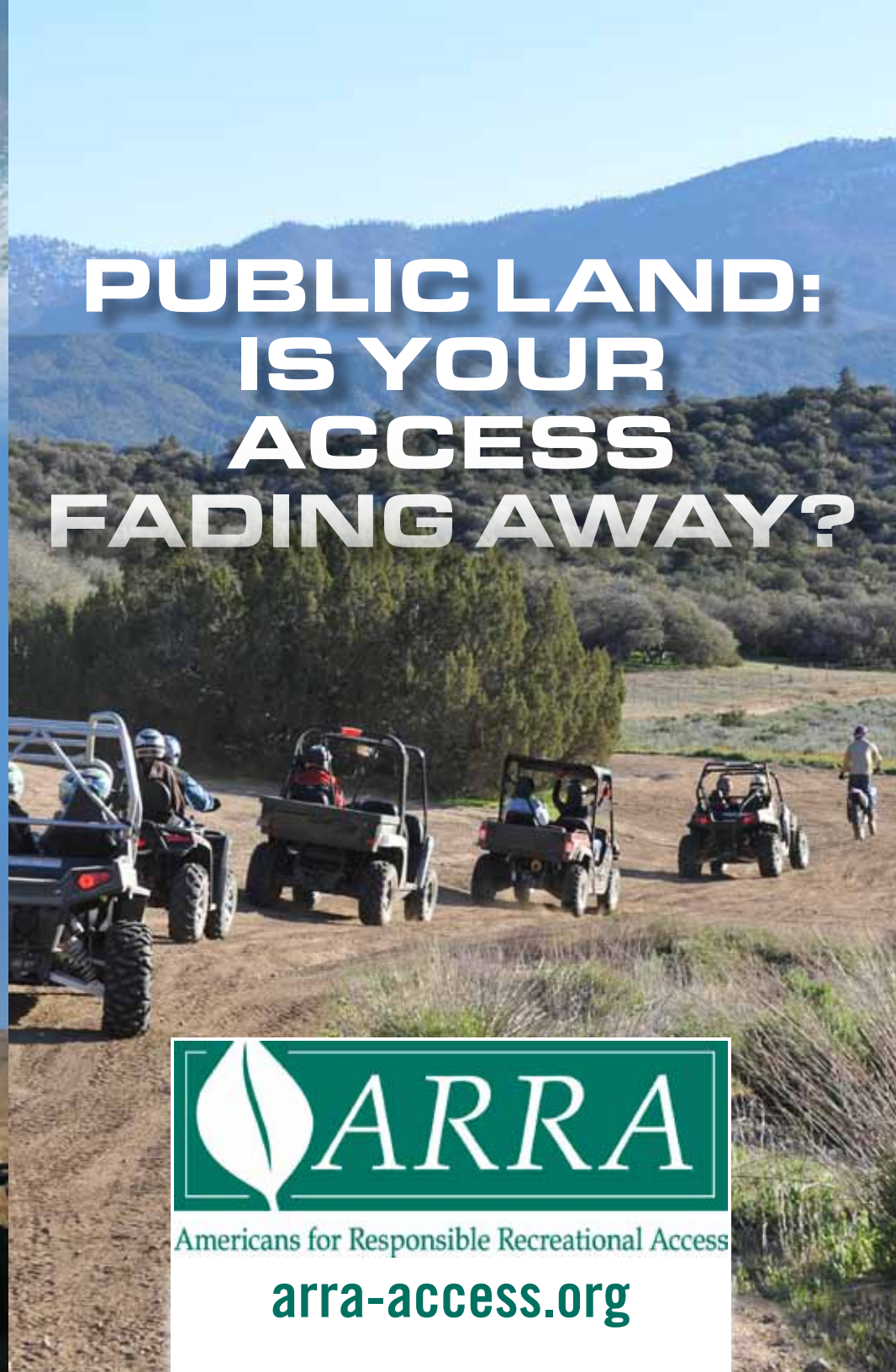

- Favors protecting our most fragile natural treasures that could be harmed by even the most responsible use.
- Opposes rulemaking and policy decisions that are made behind closed doors and supports a completely open process that allows all interested groups and individuals to have a voice in the process.
- Supports outdoor recreation as a source of jobs and economic development in rural areas.
